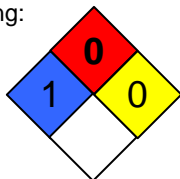

## 6. ACCIDENTAL RELEASE MEASURES

Evacuate the spill area, except for cleanup personnel. Wear NIOSH/MSHA-approved respirator and protective equipment as referenced in Section 8 below. Control spill with adsorbent pads or booms. Recover free liquid. For recovery or disposal, add inert absorbent (sand, earth, sawdust, etc.) to spill area and shovel into containers for disposal. ## 7. HANDLING AND STORAGE

**Precautions to be Taken in Storage:** Product should be stored in a dry place with temperatures above 30°F. Partially used containers should be resealed between uses for maximum storage stability.

## 8. EXPOSURE CONTROLS / PERSONAL PROTECTION
