BORDER XTRA 8L is a liquid adjuvant premix of drift reduction polymers and ammonium sulfate formulated to enhance herbicide performance on a wide range of weed species.

Aerial Application: 2.5–5% (2.5–5 gallons) of BORDER XTRA 8L per 100 gallons of spray solution.

BORDER XTRA 8L provides 8.5 lbs. of dry ammonium sulfate per 2.5 gallons.

MIXING

In the absence of specific mixing instructions found on the herbicide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation
