FIRST AID

GENERAL INFORMATION

ENVY is pigment dispersion, labeled for use on turf, trees and shrubs. A unique combination of pigments and adjuvants, ENVY improves plant aesthetics, masks injury or discoloration and improves spray coverage. ENVY also provides visual spray pattern identification for the applicator.

DIRECTIONS FOR USE

FOR USE ON GOLF COURSES, ATHLETIC FIELDS, COMMERCIAL, MUNICIPAL OR RESIDENTIAL PROPERTIES,

For best results, apply ENVY to dry plants and avoid application conditions that favor drift. To minimize staining risk, wet concrete and masonry surfaces with water prior to application and rinse with water immediately after application.

SHAKE WELL BEFORE USING.

Turf: apply 16 ounces of ENVY in 50 gallons of spray solution per acre.

Trees and shrubs: mix 16 ounces of ENVY in 50 gallons of water and apply with equipment that provides thorough coverage of the plant foliage.

Use rates will depend on turf or plant species, growing conditions and desired color.

MIXING

Fill the spray tank with a least 50% of the desired finished water volume. With agitation on, add tank mix ingredients in the following order:

- Compatibility agent, if needed. 1)
- Dry formulations (WP, DF, WDG, SP). 2)
- 3) ENVY.
- Liquid drift retardants and flowable formulations (F and FL). 4)
- Microencapsulated and suspension concentrates (ME and SC). 5)
- Emulsifiable concentrates (E, EL or EC). 6)
- 7) Solutions (S, L and LC), micronutrients, liquid or suspension fertilizers.
- 8) Additional adjuvants (COC, HSOC, MSO, NIS) and /or water conditioning agents.
- Finish filling to desired spray volume level and continue agitation.

STORAGE AND DISPOSAL

For best results, use within one year of purchase. May be stored below 32° F if thawed and thoroughly agitated before use. Keep container closed in storage. Do not allow water to be introduced. Store only in original container. Triple rinse when empty and offer for recycling. Always dispose of container in accordance with local, state and/or federal regulations. Do not reuse empty container.
