KIXYT is a low-use-rate methylated seed oil concentrate that enhances herbicide performance when compared to ordinary methylated seed oils or crop oil concentrates. KIXYT combines the cuticle penetration properties of a premium quality methylated seed oil with a proprietary surfactant system to deliver higher levels of biological performance at lower use rates than traditional oil-based adjuvants.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit





of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including KIXYT, or must have conducted a phytotoxicity test prior to use.

Kixyt may be used at 0.50-0.75% v/v (2-3 quarts per 100 hundred gal. of spray solution) the recommended use rate of conventionally formulated methylated seed oils. Kixyt should be applied at no less than 10-12 ounces per acre.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed 1.
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- 6. Emulsifiable concentrates (E, EL or EC)
- Solutions and soluble liquids (S or SL) 7.
- 8. Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants 9. (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation
