#### **GENERAL INFORMATION**

PEN-A-TRATE II is a nonionic, low-foaming, spreader/activator (surfactant) designed to improve and enhance the effectiveness of pesticides. PEN-A-TRATE II improves wetting, spreading and penetration of herbicides, insecticides, fungicides and other pesticides. PEN-A-TRATE II improves the wetability and weatherability of spray-applied chemicals, allowing them to "sheet" rather than "bead" over leaf surfaces, as well as retarding evaporation. PEN-A-TRATE II is nonflammable and contains no alcohol.



#### DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using PEN-A-TRATE II, the applicator or crops advisor must have experience with the pesticide combination, including PEN-A-TRATE II, or must have conducted a phytotoxicity test. #### **USE RATES**

0.125–0.5% v/v (1–4 pints per 100 gallons of spray solution).

#### MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed 1.
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
- 6. Emulsifiable concentrates (E, EL or EC)
- Solutions and soluble liquids (S or SL) 7.
- Liquid micronutrients and fertilizers 8.
- 9 Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Rinse container thoroughly prior to disposal. Dispose of rinsate and container in accordance with local, state and federal regulations.
