GENERAL INFORMATION

ALYPSO PLUS contains a naturally-derived surfactant that reduces the surface tension of water and improves the infiltration of rainfall and irrigation into and throughout the turf or plant root zone. The water conditioner in **ALYPSO PLUS** reduces pH and addresses issues associated with poor water quality. **ALYPSO PLUS** may be tank mixed or used in conjunction with other soil surfactants, plant protectants or plant nutrients.

ALYPSO PLUS IS DESIGNED FOR USE ON GOLF COURSES, ATHLETIC FIELDS AND RESIDENTIAL OR COMMERCIAL TURF AND ORNAMENTALS, UNDER THE SUPERVISION OF GOLF COURSE SUPERINTENDENTS, SPORTS TURF MANAGERS OR PROFESSIONAL LANDSCAPE CONTRACTORS.

DIRECTIONS FOR USE

ALYPSO PLUS can be applied throughout the growing season without fear of discoloring sensitive turfgrass or plant species. **ALYPSO PLUS** is compatible in programs with most fertilizers and plant protectants. Adjust use rates and application timing depending upon conditions.

USE RATES, METHODS AND INTERVALS

INJECTION: Inject 32 ounces (946 ml) of **ALYPSO PLUS** per one acre (.40 ha) of turfgrass or ornamentals. Monitor results to determine water infiltration and adjust rate, up or down, in 2 ounce (59 ml) per acre (.40 ha) increments, until desired level of performance is achieved.

SPRAY APPLICATION: Spray 32 ounces (946 ml) of **ALYPSO PLUS** in a minimum of 60 gallons (227 L) of water to treat one acre (.40 ha) of turfgrass or ornamentals. Monitor results to determine water infiltration and adjust rate, up or down, in 2 ounce (59 ml) per acre (.40 ha) increments, until desired level of performance is achieved.

SPRAY CONDITIONER: Mix at a rate of .25 v/v to .5 v/v (1 to 2 quarts per 100 gallons of spray solution). Conduct a compatibility test with all tank mix partners prior to the application. Prior to using **ALYPSO PLUS** as a water conditioner, read and follow the label directions of all tank mix partners.

APPLICATION INTERVAL: Use **ALYPSO PLUS** monthly throughout the growing season. The application interval may be adjusted as needed.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations.
