DUPLEX is a conditioner that sequesters hard water ions and reduces the surface tension of water.

### DIRECTIONS FOR USE

DUPLEX can be added to water in conventional spray equipment or injected into irrigation systems. Use rates and application interval vary depending upon water hardness and quality.

Dilution Rate: add 0.75 L of Duplex to 200 L (48 ounces per 100 gallons) of water. Adjust rate, up or down, in 118 ml (4 ounces) increments until the desired water quality is achieved.

### STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations.
