5. FIREFIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Handling Procedures: Avoid inhalation of vapor or mist. Avoid contact with skin and eyes. Mix thoroughly. Do not freeze. Freezing will affect the physical condition but will not damage the material. Thaw and mix before using. Ethylene oxide may collect in container head space. Provide adequate ventilation.

Storage Procedures: Keep container tightly closed in a dry and well-ventilated place. Keep away from incompatible materials to be indicated by the manufacturer. Do not freeze. Do not mix with incompatible materials.

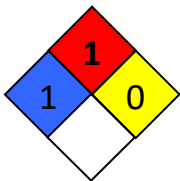
