FIRST AID

GENERAL INFORMATION

PRECIP is formulated to address hydrophobicity and water acceptance in soils. PRECIP increases the infiltration of water into the soil and improves the length of hydration. PRECIP should be applied as a preventative water management strategy.

PRECIP IS DESIGNED FOR USE ON GOLF COURSES, ATHLETIC FIELDS, RESIDENTIAL TURF, COMMERCIAL TURF, ORNAMENTALS AND GREENHOUSES UNDER THE SUPERVISION OF GOLF COURSE SUPERINTENDENTS, SPORTS TURF MANAGERS, PROFESSIONAL LANDSCAPE CONTRACTORS OR GREENHOUSE GROWERS.

DIRECTIONS FOR USE

To improve performance and avoid the risk of temporary leaf tip discoloration caused by certain environmental conditions that may exist at application, apply PRECIP using the application techniques described below.

APPLICATION TECHNIQUES

Immediately following application, irrigate with enough water to move PRECIP into the root zone at the desired depth of performance. Apply PRECIP directly before rain or during rain if irrigation is not available.

USE RATES

Spray Application: Apply PRECIP at a rate of 2 to 8 ounces (59 to 237 ml) in a minimum of 1 gallon (3.79 L) of water per 1,000 ft² (92.9 m²). Reapply every 14-28 days at the 2 to 4 oz. per 1,000 ft² rate. Use higher rates for longer durations.

Apply PRECIP at a rate of 87 to 349 ounces (2.6 L to 10.3 L) in a minimum of 44 gallons (167 L) of water per acre (0.40 ha).

Irrigation Injection: Inject PRECIP at a rate of 32 ounces (1 L) per acre (0.40 ha).

Seeding and Sprigging: Apply PRECIP at a rate of 4 ounces (119 ml) in a minimum of 1 gallon (3.79 L) of water per 1,000 ft² (92.9 m²) after seeding or sprigging. Irrigate directly after application with a volume of water to sufficiently wet the seeded surface to a 1/2-inch (13 mm) depth. Volume of water needed may vary with soil type.

Drench (for ornamental trees, plantings and container pots) Dilute 8 to 16 ounces (237 to 474 ml) of PRECIP in 100 gallons (279 L) of water and apply as a drench application.

TANK MIXING

Unless prior experience has proven the combination to be effective, compatible and safe on the desired turf or plant species, it is not recommended that PRECIP be tank mixed with other pesticides, fertilizers, micronutrients, bio-stimulants or other such products.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations. Do not store near heat or open flame.
