FIRST AID

GENERAL INFORMATION

SALIA is an APE/NPE free, high surfactant oil concentrate formulation with built in drift reduction and deposition technology. SALIA is used at 50% of the traditional use rate of ordinary crop oil concentrates or methylated seed oils. SALIA is an ideal tank mix partner for enhancing the performance of a wide range of herbicide tank mixes, particularly under tough or stressful growing conditions.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit

of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including SALIA, or must have conducted a phytotoxicity test prior to use.

SHAKE WELL BEFORE USING.

FOR USE WITH HERBICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY. NOT FOR AQUATIC USE.

USE RATES

Ground: Use 3–4 pints per 100 gallons of spray solution or a minimum of 8–12 ounces per acre.

Drones / UAVs: Use a minimum of 6-8 ounces per acre.

Use higher rates per acre with lower spray volumes.

(should not exceed 2.5% v/v).

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, HS-MSO, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature and agitate before use.* Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. CONTAINER DISPOSAL: Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
