ENDURON PSI's high expansion formulation produces large volumes of thick, long-lasting foam that allows applicators to drop more foam at higher operating pressures and application speeds. In side-by-side field tests, ENDURON PSI has outlasted ordinary marking foams by over twice as long.

DIRECTIONS FOR USE

Thoroughly clean and neutralize application unit foam tank with an approved foam tank cleaner, such as AGRI-KLEEN™, prior to using ENDURON PSI for the first time. Call 1-800-323-8351 for more information. ENDURON PSI is tolerant to hard water conditions and does not require an additional water softener. SHAKE WELL BEFORE USING.

USE RATES

Use ENDURON PSI at a 100:1 dilution rate (12-13 ounces of ENDURON PSI per 10 gallons of water).

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
