FIRST AID

GENERAL INFORMATION

Persist Advanced is a low-use-rate, methylated seed oil that has been enhanced with unique silicone surfactants to provide superior leaf surface coverage and penetration compared to ordinary silicone surfactant blends.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including **Persist Advanced**, or must have conducted a phytotoxicity test prior to use. Do not use this product in a manner inconsistent with labeling. **Persist Advanced** increases the activity of many pesticides. Therefore, care must be taken when treating sensitive crops during periods of drought stress, high temperatures or high humidity.

USE RATES

Ground: 1-5 pints/100 gls of spray solution

Aerial: 2-6 pints/100 gls of spray solution

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension
6. (LC, SC, ME, CS)
7. Emulsifiable concentrates (E, EL or EC)
8. Solutions and soluble liquids (S or SL)
9. Liquid micronutrients and fertilizers
10. Water conditioners and other adjuvants (**Persist Advanced**) (COC, HSOC, MSO, NIS)
11. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect from freezing. If product freezes, warm to room temperature before use. Keep containers sealed when not in use. Store in original container only. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
