USE RATES

Use 1–2 ounces of TRACER HOT PINK Marking Foam Colorant per 10 gallons of foam mixture.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and agitate before use. Store in cool, dry, well-ventilated areas away from direct sunlight. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Rinse container thoroughly prior to disposal.
