GENERAL INFORMATION

QUICKIN is a multi-purpose surfactant that significantly reduces the surface tension of water and improves the movement of rainfall and irrigation into agricultural soils.

QUICKIN IS DESIGNED FOR USE ON ROW CROPS, FRUITS, NUTS, VINES OR VEGETABLES.

DIRECTIONS FOR USE

QUICKIN can be applied throughout the growing season without fear of discoloring sensitive crops. To achieve best results, apply QUICKIN with the first irrigation cycle and schedule subsequent applications based on climatic conditions and the water needs of the crop. QUICKIN may be applied through any type of irrigation system including drip, tape or overhead sprinkler.

APPLICATION TECHNIQUES

IRRIGATION INJECTION: Apply through an irrigation system utilizing drip tubes, tape, micro emitters or overhead sprinklers. Do not apply QUICKIN through earthen ditches. Prior to mixing QUICKIN with water conditioners or plant nutrients, perform a jar test to test compatibility. Agitation is recommended in fertigation tanks to ensure uniform injection of nutrients and QUICKIN. Always use back-flow prevention when injecting QUICKIN or other injectable products.

SPRAY APPLICATION: On annual crops, apply QUICKIN alone or in combination with nutrients, prior to planting. On perennial crops, direct the spray to the soil surface at the base of the plant. Irrigate immediately after all spray applications to move product into the soil.

NOTICE: DO NOT MAKE A SPRAY APPLICATION OF QUICKIN TO THE FOLIAGE OF ANNUAL OR PERENNIAL CROPS AS PLANT INJURY MAY OCCUR.

USE RATES

Initial Application: Apply QUICKIN at the rate of 1-3 quarts per acre (2.5 - 7.5 liters per hectare).

Subsequent Applications: Apply QUICKIN at the rate of 1 pint per acre (1.17 liters per hectare) or increase to meet the needs of the crop, based on environmental conditions.

APPLICATION INTERVAL

Apply QUICKIN every 3 to 4 weeks. The time between applications may vary by crop, soil type or crop response to environmental conditions. The use of a soil tensiometer is encouraged to determine the required irrigation interval.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Store in original container only and do not reuse empty container. Rinse container thoroughly, disposing of rinsate and the container in accordance with federal, state and local regulations.
